



Licence for the filming, duplication, broadcast, streaming and upload to social media sites of performances of: **Jill & Fred's Most Hysterical Historical Adventure**

This Licence is a legal agreement between the purchasing institution ("You") and Edgy Productions Ltd (the "Company"). By accepting this Licence You declare that you are acting on behalf of the institution which has purchased the performance package bundle for **Jill & Fred's Most Hysterical Historical Adventure**. A copy of this Licence will be kept at the Registered Office of the Company, and must be kept by You, for a period of 3 years from the date of issue.

This Licence Agreement relates to **Jill & Fred's Most Hysterical Historical Adventure**, produced by the Company and purchased by You. Upon receipt of this Agreement, Edgy Productions Ltd. grants you a non-exclusive non-transferable licence to make video and audio recordings, duplicate, broadcast, stream and upload to social media sites performances of the product, performed within the confines of the purchasing institution, on condition that you agree to the following:

1. Digital and physical copies of the original video and/or audio recording of the Product may be made and sold only within the confines of the Purchasing Institution.
2. The confines of the purchasing institution are defined as the main site of that institution and any additional sites belonging to or leased by the institution, for example local theatres or schools. The Licence does not allow the recording of public performances or broadcasts outside the Purchasing Institution.
3. This licence agreement is not transferable.
4. Multiple copies of the Product may be sold to the same individual on the understanding that no hiring, broadcasting or re-recording of the Product is permitted.
5. You may not copy, lend, loan, rent, sell or distribute the Product (or copies) to individuals with which You have no direct relationship. This should be interpreted to mean copies may only be sold to performing cast and crew and their immediate family members.
6. Recordings made by members of the audience can only be sold by You under the terms of this licence.
7. You agree to make the following announcement prior to any performance where video recording is permitted under the terms of this licence "Recording of this performance by members of the audience is permitted for personal use only".
8. Copies of the Product must be marked as follows: "Copyright Edgy Productions Ltd. All rights reserved. No unauthorised copying, hiring, renting, public performance or broadcasting of this footage is permitted"
9. You are responsible for taking reasonable measures to prevent access to the Product by unauthorised persons, and you are responsible for terminating any unauthorised access of which You have notice or knowledge. You agree to co-operate with the Company in any investigation of unauthorised access to or use of the Product.

Any filming of performances of the product outside the Purchasing Institution, or by 3rd parties not directly employed by You will constitute a breach of this Licence Agreement by You. Any attempt to use or distribute or sell the Product, or copies of the Product, to individuals not directly associated with the Purchasing Institution will constitute a breach of this Licence Agreement by You.

This Agreement constitutes the entire Agreement between the parties hereto and supersedes all prior oral and written and all contemporaneous oral negotiations, commitments and understandings. No amendment of this Agreement shall be effective unless it is in writing and signed by the parties hereto. If any provision of the Agreement is found to be unlawful or void then that provision shall be severed from the Agreement and will not affect the validity of the remaining provisions. This Agreement shall be governed by the laws of England.
