



Licence for the performance of: **Jill & Fred's Most Hysterical Historical Adventure**

This Licence is a legal agreement between the purchasing institution ("You") and Edgy Productions Ltd (the "Company"). By accepting this Licence You declare that you are acting on behalf of the institution which has purchased the performance package bundle for **Jill & Fred's Most Hysterical Historical Adventure**. A copy of this Performance Licence will be kept at the Registered Office of the Company, and must be kept by You, for a period of 3 years from the date of issue.

This Licence Agreement relates to **Jill & Fred's Most Hysterical Historical Adventure**, produced by the Company and purchased by You. All materials including but not limited to the CD, digital tracks, script and packaging (hereafter known as the "Product") and any upgrades or modifications of the Product may only be used in public performances under the terms of this Licence. Upon acceptance of the Licence, the Company grants you a non-exclusive non-transferable permission to use the Product for non-private use, on condition that you agree to the following:

1. The Product may only be used within the confines of the Purchasing Institution or a venue declared in writing by you and agreed by the Company.
2. This Licence Agreement is not transferable.
3. You may not copy the Product in whole or in part, with the exception that **ONE** copy of the script and score may be made for each member of the performing cast and production crew, and associated artwork may be made and adapted for your own promotional purposes.
4. The Product is licensed for a maximum of 5 performances to a public audience, for up to one year from the date of purchase. If you plan to perform more than 5 times, or after one year from the date of purchase, you agree to inform the Company and to purchase an extended licence.
5. The confines of the purchasing institution are defined as the main site of that institution and any additional sites belonging to or leased by the institution, for example local theatres or schools.
6. You are responsible for taking reasonable measures to prevent any form of recording of any performance of the Product by unauthorised persons other than staff of the Purchasing Institution, and You are responsible for terminating any unauthorised access to such recordings of which You have notice or knowledge. You agree to co-operate with the Company in any investigation of unauthorised recording, duplication, streaming or public posting of performances of the Product.
7. You agree to inform the Company of the dates of performances of the Product as outlined above no later than 28 days before the first performance.
8. Up to 2 representatives of the Company reserve the right to attend any performance of the Product by You.

Any attempt to perform the Product outside the Purchasing Institution without the written consent of the Company will constitute a breach of this Licence Agreement by You. Any filming and broadcast of performances of the product outside the Purchasing Institution, or by 3<sup>rd</sup> parties not directly employed by You will constitute a breach of this Licence Agreement by You.

This Agreement constitutes the entire Agreement between the parties hereto and supersedes all prior oral and written and all contemporaneous oral negotiations, commitments and understandings. No amendment of this Agreement shall be effective unless it is in writing and signed by the parties hereto. If any provision of the Agreement is found to be unlawful or void then that provision shall be severed from the Agreement and will not affect the validity of the remaining provisions. This Agreement shall be governed by the laws of England.
